- b) Makes any false or misleading information / declaration and knowingly sent copies of forged documents which got detected at a later date,
 - c) Supplied stores of inferior quality,
 - d) Rendered services of inferior quality than the contracted ones,
 - e) Failed to execute a contract or failed to execute it satisfactorily,
 - f) Is declared bankrupt or insolvent,
 - g) Failed to submit the required documents / information for renewal of registration, where required,
 - h) Is barred / black listed by Government Agencies / Statutory bodies, other Shipbuilding Yards, PSUs and with whom commercial transactions have been suspended for sufficient and justifiable reasons
